

3 **FACTS**

4 On June 20, 2019, the OPA scheduled the factual Hearing to commence
5 on August 12, 2019 until August 14, 2019 at 9:30 a.m.

6 Appellant TakeCare did not anticipate the Hearing date to be scheduled
7 for August 12, 2019 and requests that the current date be continued from

13 rescheduling of the Hearing date.


14 **CONCLUSION**
