SCHEDULING ORDER

Public Auditor Doris Flores Brooks and Hearing Officer Ignacio C. Aguigui, Esq., convened a pre-hearing conference in the above-named appeal on August 2, 2013, on notice duly given to all parties of record. Present for the Appellant was the President of Triple J Enterprises ("Triple J"), Mr. Jeffrey B. Jones. Present for the Department of Public Works and the General Services Agency (the "Government") was legal counsel Assistant Attorney General Fred Nishihira.

Upon consideration of the record and the statements of counsel and the parties made at the pre-hearing conference, the Public Auditor adopts and orders the following:

- 1. On July 26, 2013, the Government filed its *Objection to Appeal, Motion to Dismiss* ("Objection/Motion"). Accordingly, Triple J shall file and serve its response or opposition to the Government's Objection/Motion no later than 5 p.m., August 16, 2013. The Government shall file and serve its reply, if any, to Triple J's response or opposition no later than 5 p.m., August 23, 2013.
- 2. Triple J informed the Public Auditor and the parties that on August 2, 2013, it filed its comments on the Government's Agency Report. Accordingly, the Government shall file and serve its rebuttal, if any, to Triple J's comments within the time period allowed by

relevant provisions of the Rules of Procedure for Procurement Appeals (2 GAR §§ 12101 et seq.)

- 3. No later than 5 p.m. August 5, 2013, the Government shall give notice of this Appeal to all Interested Parties, in the form and substance specified by the Rules of Procedure for Procurement Appeals. The Government shall also serve a copy of this Scheduling Order on such Interested Parties, as the Government is the entity most likely to have the correct names and addresses for such Interested Parties.
- 4. After the parties have submitted to the Public Auditor the filings described in this Scheduling Order, and after the Public Auditor has reviewed and considered such filings, notice will be given of any further proceedings in this matter that may be deemed necessary.
