

Comes now Appellants Triple J Enterprises and Cars Plus, LLC and Respondent General Services Agency (GSA) who stipulate and agree to resolve the above referenced appeals and to dismiss these actions as follows:

1. GSA agrees to ratify and award the sale of eight (8) interceptors to Triple J Motors.

- 2. GSA agrees to award two (2) interceptors to Cars Plus LLC, at their bid prices.
- 3. Cars Plus agrees to provide a warranty that complies with the terms of the bid.
- 4. The Parties agree that each shall bear their respective fees and costs.
- 5. The Parties agree to vacate all dates on the scheduling orders.
- 6. The Parties agree that this is a full and final settlement of OPA-PA-13-11, OPA-PA-13-12, and OPA-PA-13-14.
- 7. Independent Advice of Counsel. Each party represents and declares that it has or could have received independent advice from its respective attorneys with respect to the advisability of making the settlement provided for herein and with respect to the advisability of executing this Agreement. Each party further represents and declares that it has not relied upon any statement or representation by the other party or of any of its partners, agents, employees, or attorneys in executing this Agreement or in making the settlement provided for herein, except as expressly provided for herein.
- 8. **Voluntary Agreement.** Each party represents and declares that it has carefully read this Agreement, that it knows the contents of this agreement, and that it has signed the same freely and voluntarily. By entering into this agreement the Respondents do not admit to any legal liability other than as may be created under this agreement.

NOW THEREFORE, the parties agree and request the Office of the Public Accountability to dismiss with Prejudice the above captioned appeals.
