## **FORESTRY AND SOIL RESOURCES**



Through efforts of Guam Forestry and the Guam Fire Department, there were less fires in 2021 with a total of 177 wildfires that burned approximately 3,624 acres of land (2.67% of total area). Furthermore, in this fiscal year, the Guam Forestry nursery propagated 12,000 acacia trees and 4,500 assorted native trees to support the Forest Stewardship program objectives. Also in assistance with the stewardship plan, 550 assorted native trees were planted on a 4-acre footprint within the COTAL Conservation Reserve.

## **BIOSECURITY**

The Biosecurity Division serves as the Department of Agriculture's center for Biosecurity and Agricultural Quarantine at the Plant Inspection Facility. The Plant Inspection Section operates a federally certified plant inspection station for Guam and others in the region. The Plant Inspection Facility inspects live plants with pest identification determinations performed

The Division of Aquatic and Wildlife Resources (DAWR) monitors, manages and protects fish, coral reefs, and wildlife resources for enjoyment by the people of Guam. Fisheries conduct fishing effort surveys, maintain recreational fishing ramps, conduct research on fish species and their habitats, and provide educational opportunities and outreach. The Wildlife Section produces ko'ko' and sihek for reintroduction into predator-reduced areas, conducts bird and bat surveys, public awareness campaigns, hunter safety classes, and hunting derbies.





All sources received during the fiscal year 2021 were significantly higher than in previous years. In 2021, the total funds increased by 67% compared to 2020.





The total amount expended in the fiscal year 2021 was \$6.8M. This is an increase of 9% compared to 2020, mainly from supplies using federal funds, and miscellaneous and utilities using other funds.




#### **Approved Funding to Combat Brown Tree Snakes (BTS)**

## **CHALLENGES**



Traditional brown treesnake control tools are lure-based and are not working with so many birds and lizards present. Only visual searching and hand-removal of snakes are working to control the population. DAWR is partnering with the Office of Insular Affairs, US Fish & Wildlife Service, USDA APHIS Wildlife Services, and community partners to eradicate snakes from Dano'.

Guam lies within the typhoon belt which leads to an average of three tropical storms and one typhoon each year. Natural events and disasters can cause contaminated bodies of water, loss of harvest or livestock, destruction of irrigation systems, and damages in other agricultural infrastructure.

Climate on Guam



Because of wildfires and the degraded landscape of Guam, the water quality and water supplies are at risk of deteriorating. Movement of sediment from erosion into waterways is a problem associated with poor land cover which reduces the quality of surface water, domestic water supplies, and fragile reef systems.

## MOVING FORWARD

**Phase One: Development of an** Island-wide HCP

The Habitat Conservation Plan (HCP) involves input from stakeholders in local and federal government agencies, and community groups working together. "The creation of an Island-Wide HCP will enable us to protect habitats for endangered and threatened species while providing a course of action for responsible development," said Chelsa Muna-Brecht, Director of DOAG.



Field-to-Fork Event

The Field-to-Fork event is to promote safe, responsible, and ethical hunter development and to help facilitate the 3Rs: Recruit new hunters, Retain current hunters, and Reactivate former hunters. The event also encourages community contributions to Guam's food security and active participation in reducing the damage caused by deer and pigs to Guam's island ecosystem.



**Spay and Neuter Island Pets (SNIP)**  SNIP's goal is to create a sustainable impact on the animal population of Guam, decrease animal suffering, and increase community education that addresses the issue of Guam's stray animal population. The program is hoping to open the clinic to the public for non-GAIN adopted pets around mid 2022.
