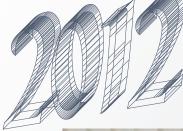

The U.S. Congress created the Territorial Government of Guam as a separate taxing jurisdiction by enactment of the Organic Act of Guam in 1950. Section 31 of the Act provides that the income tax laws in force in the United States shall be the income tax laws of Guam, substituting Guam for the United States where necessary and omitting any inapplicable or incompatible provisions. The U.S. Internal Revenue Code with such changes constitutes the Guam Territorial Income Tax Law.

There is the usual range of other types of local taxes such as, real property, liquor, tobacco, liquid fuel, automotive surcharges, gross receipts, use, and hotel occupancy. However, there is only one taxing authority in the Territory, the Government of Guam. There are no separate municipal, county, school district or improvement district taxes. Also, there is no general sales tax imposed directly on the consumer.

AGENCY 2013 GOALS

- Continuing with the development of the revaluation of the property tax assessments.
- To conduct aggressive investigation on tax violations and to increase case referrals for prosecution.
- Timely assessments and aggressive collection efforts to increase revenues and decrease accounts receivables accordingly.
- To enhance online services for renewal or filings for licenses, registrations, and income tax forms, to include the establishment of mandatory filings for GRT/BPT.
- To successfully implement of the Transaction Processing System (TPS).
- To increase efforts to regulate holders of licenses to protect consumers of Guam from unsafe, unsound, and unfair practices.

AGENCY OBJECTIVES

- Improve and enhance the tax system so as to decrease the burden that any such system imposes on the public
- Provide quality services in a cost-effective and timely manner through maximizing the use of all resources available
- Administer, enforce, and educate the public of all tax laws and business regulations to attain the highest degree of voluntary compliance, and the trust and confidence of the general public

AGENCY CHALLENGES

- Maintaining adequate division staffing to meet the growing demand for services
- Recruitment and retention of personnel to replace those who have resigned or retired.
- To develop and maintain timely assessments and collections of accounts receivables
- Customer service issues such as answering telephone calls and/or long waiting periods in line for services.

AGENCY FUTURE OUTLOOK

- Customer Service Training to provide for:
 - Efficient and quality public services
 - Effective communication for awareness of agency procedures for services
- Tax Enforcement Training to include specialized training with the Internal Revenue Service to provide for:
 - Increase in enforcement efforts to reduce activities of tax law violators
 - Increase in Examination cases to educate Taxpayers with tax laws and filing responsibilities
 - Increase in collection activity and aggressive collection efforts to reduce accounts receivable.
- *Effective and efficient E-Commerce services to provide for:* - Efficient services for the convenience of taxpayers.
- Increase in regulatory enforcement to:
 - Protect the consumers of Guam
 - Educate licensees of their responsibilities

AGENCY ACCOMPLISHMENTS

- Total refunds paid in 2012: \$126,054,045
- Implementation of the GPAS Tax Mapping System
- Passport staffing. Diplomatic Security Service Team reported that this office although understaffed and with minimal resources has the lowest error rate for passport processing in the nation.
- Outsourced Driver's Road Test and implementation of the Online Driver's Scheduler
- Motor Carrier Safety Assistance Program has successfully completed Program Review by the Federal Motor Carrier Safety Administration receiving an outstanding performance and outstanding accomplishments of our safety program.
- Adopted the regulations for mortgage loan originators to implement the provisions of the Guam Secure and Fair Enforcement for Mortgage Licensing Act of 2010 under our Regulatory Division.
- Established networking with various federal law enforcement and investigative divisions under our Criminal Investigation Branch.
- Phase 1 of the revaluation project has been completed resulting in 1,500 field inspections of which 291 new buildings assessments have been included into the assessment roll by Real Property Tax Division.
