About Us

The Department of CHamoru Affairs (DCA) with its divisions of *I Faninadahen Kosas Guåhan* (Guam Museum), *I Sengsong CHamoru* (CHamoru Village), *I Inaligao, Tinige', Yan Fina'nå'gue* (Research Publications & Training), *I Faninadahen Fino' yan Kotturan CHamoru* (CHamoru Language & Culture), and *I Sagan Rikuetdon Guåhan* (Guam Archives) was established through Public Law 25-69. This law established the department as a government entity that reorganizes the perpetuation, promotion, and the preservation of our CHamoru Heritage.

Our Mission

To create, develop, implement and maintain an integrated program for the preservation, promotion, and advancement of the native CHamoru people of Guam. It is intended that the public corporation be the guiding force in all aspects of CHamoru culture, language, preservation, education, arts, humanities, and history, through public policy, advocacy, research, publication, authentication, restoration, presentation, and production, and by providing and overseeing a repository for historical documents, cultural artifacts and documentary and narrative film and video.

I Inaligao, Tinige', Yan Fina'nå'gue (Research, Publication and Training) is responsible for developing an articulated curriculum and course texts for mandated courses in Guam schools and institutions of higher learning relating to Guam's history, language and culture; conducting research, publishing and producing multi-media materials relating to the CHamoru Heritage; and providing training to promote increased understanding of CHamoru language. Throughout the fiscal year, the Department of CHamoru Affairs has sold Hale'-ta books to our community and our CHamoru people from afar who have shown great interest in our political, social, economic and cultural history.

I Sengsong CHamoru (The CHamoru Village) on March 2020, through the Governor's Executive Order, the CHamoru Village was closed due to the Covid-19 Pandemic. On May 2020, the CHamoru Village opened its doors allowing food merchants to sell with curbside services. A couple weeks later, the retail merchants were allowed to open with limited capacity following DPHSS guidelines. Between March 2020 - September 2020, the CHamoru Village lost two (2) food merchants and four (4) retail vendors. Fortunately, the CHamoru Village signed leases for three (3) food merchants and four (4) retail vendors. A good comeback for the CHamoru Village as it gained one (1) vendor during this period. The Wednesday Night Market was open during the 1st quarter of FY 2020 and remained closed from March 2020 to the end of the fiscal year. Despite the closure of our most popular night spot on a Wednesday night, the CHamoru Village was awarded Pika's Best of Guam for 2020 for Best Tourist Spot.







Ha'ånen Familia: Batik Simplified for Kids 01.18.20 | 10:00 AM to 12:00 PM





- ♦ I Inaligao, Tinige', Yan Fina'nå'gue (The Research, Publications and Training) will continue to perpetuate, promote, and preserve the CHamoru heritage and culture by promoting the sell of its Hale'-ta publications in all media and digital platforms. I Inaligao, Tinige', Yan Fina'nå'gue intends to reproduce publications that have been sold out due to its popularity.
- ◆ I Sengsong CHamoru The Government of Guam is requesting funds through the Department of Interior to renovate and update I Sengsong CHamoru as a retail-commercial outlet and expanded market opportunities for small business entrepreneurs, retail vendors, cottage product manufacturers, local instructional cooking courses, and farmers market. Part of the renovation project is to enclose the Sagan Mañaina-ta huts which will allow for the repurposing of the structures for local produce sales, retail and crafts merchants, and food establishments.
- ◆ The Guam Museum will continue to present a unique and exciting opportunity for the community to experience and enjoy the island's history and culture. The museum continues to share the best of Guam and promote a sense of place through its Permanent Exhibit: *I Hinanao-ta*, Journey of the CHamoru People. The Guam Museum will also continue to reach various audiences through educational activities, local art and performing arts, language, and family friendly events such as HITA Lecture Series and *Ha'anen Familia* geared towards children's interactive aspirations. The *Kosas* Board of Advisors recommends the submission of the Museum Assessment Program (MAP) and furthermore recommends that the Guam Museum seek option #1 titled: Organizational under American Alliance of Museums (AAM) Accreditation Excellence Program. The MAP is the first step in attaining accreditation. This assessment is necessary for ensuring the organization's capacity, leadership, structure, professional ethics, practices, and standards are in line with national museum standards. The Guam Museum mandate directly supports Guam's history and culture.
- ◆ The Department of CHamoru Affairs and its divisions will continue to take an active role in preventing the spread of the Novel Coronavirus (COVID-19) based on the Governor's latest Executive Order. The Guam Museum will slowly open its doors by accepting appointments only for tours, small meetings, conferences, workshops, events, ceremonies, and/or receptions. The CHamoru Village will continue to push notifications to its merchants to practice social distancing and other safety measures.
