The Guam Department of Public Health and Social Services (DPHSS) was created by 5 GCA, Government Operations, Chapter 3, Departments of the Government, Article 1, §3111, Department of Public Health and Social Services. The Director of DPHSS is appointed by the Governor with the advice and consent of the Guam Legislature. DPHSS employs approximately 414 full-time employees that provide support to the five divisions: Division of Public Health, Division of General Administration, Division of Environmental Health, Division of Senior Citizens, and Division of Public Welfare. These divisions are further organized into bureaus, programs, and sections (as applicable) that provide services to our island community. We are committed to embracing an organizational culture of continuous learning and development of all staff in order to become a stronger public health workforce for Guam.

The Festival of Pacific Arts that took place on Guam from May 22-June 4, 2016 was a great success due in part because of the hardworking and dedicated staff at the Department of Public Health and Social Services. DPHSS staff started planning and preparing for FestPac well over a year before the arrival of the delegates. DPHSS collaborated with the Secretariat of the Pacific Community (SPC), U.S. Centers for Disease Control, and community partners. Public Health nurses manned the Paseo First Aid Station and the medical staff at the NRCHC extended their clinic hours to accommodate the health needs of the FestPac participants. DEH staff conducted daily inspections of the food vendors at Paseo and Chamorro Village and manned spray booths in order to prevent mosquito-borne disease outbreaks. DPHSS enhanced their syndromic surveillance so that any unusual occurrence could be addressed immediately.

Our Way Forward towards a healthier, diabetes-free Guam

The Guam Diabetes Prevention and Control Program in collaboration with the Guam Diabetes Control Coalition recently completed the five year strategic plan for Guam. The 2016-2020 Strategic Plan for “Diabetes Prevention and Control in Guam” represents the combined input of numerous and varied stakeholders, representing the public sector, the private sector, the health care professionals, the faith community, the academic sector and, most importantly, community members who have been affected by diabetes. It is meant to outline the first steps towards attaining the vision of a healthier Guam, freed from the burden of diabetes.

We liken the process of implementation to building a healthy home – the foundation consists of strong community partnerships and collaboration. The four pillars of the house represent the four key areas of work. The pillars support a ceiling that embodies our five-year strategic goal of a 20 percent reduction in diabetes prevalence and mortality – “20 by 2020.”

The ceiling holds up the roof, which encapsulates our ultimate vision for our island community.

We realize that there are formidable barriers, but we are optimistic about the impact and potential achievements when our community is mobilized to act strategically in advocating for our goal and vision. We intend to monitor progress periodically, and agree that our strategic plan is a “living” document that may need to change as we go through the next five years. We will learn as we go.

With dedication, passion and perseverance, we believe we can generate change to improve our island’s health. We commit ourselves to making this positive change happen.
