






OUR DEMOGRAPHICS: SY 2019-2020









Since SY 2016-2017 to SY 2019-2020, CHamoru has always been the predominant ethnicity amongst GACS students.





In SY 2019-2020, the top two languages spoken at home were English (55%), Chuukese (26%)




The citizenship of the students are mainly US and FSM, with 47% and 2% respectively.

OUR PERFORMANCE: SY 2019-2020

As a result of COVID-19, the Governor's executive order haled in-class instruction. Since all schools were shut down, the U.S. Department of Education waived the administration of the ACT/ASPIRE for school year 2019-2020. Hence, there is no district wide assessment for this year. However, the school continued to administer internal assessment to determine students' achievement with the resource available at that time.

ELEMENTARY



The table on the left shows that there are 75% of 1st graders; 34% of 2nd graders; 35% of 5th graders; and 17% of the kindergarten students who fall under the "Below Benchmark" by the end of the SY 2019-2020. There were 25% of 1st graders, 40% of 3rd graders, 56% of 4th graders, 35% of 5th graders and 80% of kindergarten students who were "Near Benchmark" by the end of the same school year. Thirty-one percent of 2nd graders, 25% of 3rd graders, 31% of 4th graders, 33% of 5th graders and 2% of kindergarten students were placed "On Benchmark" at the end of the school year.

MIDDLE SCHOOL

Assessment issued to middle school students this school year were derived from Direct Instruction program, teacher made quizzes and tests and a variety of assessment included in the Edgenuity program as well. During this year, the Literature course was extracted from the Direct Instruction umbrella as it was discovered that reading material was lacking and students were held from the course until the prerequisite class in its entirety reached benchmark. Through the Marks Analysis, the progress and success of the students were tracked and monitored on a quarterly basis.


HIGHSCHOOL

In the absence of the district-wide assessment, high school students' progress was assessed with the assessment tools available on Edgenuity such as the cumulative and final exams. These served as a pre- and post-test in grades 9 – 12. Lesson quizzes and unit tests were another source of classroom assessment. In addition, GACS has implemented the use of MARKS Analysis to track student growth and progress on student grades per quarter. Reports are generated to compare the grades of students every quarter.



OUR CHALLENGES AND FUTURE OUTLOOK:

Accreditation

On February 8, 2020 GACS submitted the Self-Study Report to WASC. The accreditation body acknowledged receipt of the report on February 12th and at that time, we were informed that the visiting team may keep the "withheld candidacy" status for grades 6-12 which will result in GACS losing operations over secondary grade levels. With this, GACS decided to seek the opportunity to acquire accreditation from Cognia. On February 18, 2020, GACS submitted its application to Cognia. A Readiness Review with Cognia representatives took place on February 20, 2020 following the submission of GACS application. After the Readiness Review, GACS went through an Engagement Review with Cognia on April 15, 2020. Guahan Academy Charter School received its 5 years accreditation status by Cognia on May 2020 for grades K-12.

Accomplishment

The surge of COVID-19 caused all schools on island to shut down. GACS was able to push through with the accreditation process online and received accreditation status until June 30, 2025. The students, especially the graduating class was able to continue instruction with the use of Edgenuity Program. A total of fifteen (15) students graduated in time as GACS received its accreditation. The "Grad & Go" ceremony was held at the school campus as shown in the photo below.
