- GOAL 5 The ILACS management will ensure that operational activities will meet high standards of accountability and resources will be utilized effectively.



OUR PERFORMANCE

It should be noted that three point data is necessary to indicate a trend. This is only iLearn's second year with ACT Aspire.

In order to obtain an ELA score with ACT Aspire, the English, Reading, and Writing subtest needs to be taken. In SY2016-17, ACT Aspire was purchased through GDOE and the Writing Subtest was not included. Therefore, iLearn Academy had an incomplete set of data.

In order to obtain a STEM score with ACT Aspire, the Writing, Math, and Science subtest needs to be taken. In SY2016-17, the subtest for Writing and Science was not included. Therefore, iLearn Academy's data is incomplete. However, iLearn Academy Charter School plans to complete all subtest to ensure that we would be able to acquire the necessary scores to create a conclusive report.

OUR FINANCES

FY2017 Financial Highlights


- The assets of the School exceeded its liabilities at the close of fiscal year by \$ 7,072 (net position). Revenue ↑ by 34.65% and Expenditures ↑ by 37.61% as a result of an increase in student enrollment and the increase in allotted amount per enrollee as authorized by P.L. 33-185. The Federal Consolidated Grant also caused an increased through in-kind contributions.
- Enrollment at close of fiscal year is 500 students as authorized by P.L. 33-185, Ch. II, Sec. 2.

ORGANIC GROWTH

iLACS is well into it's fourth school year. iLACS is currently seeking appropriation to support the organic growth of it's student population. Goals for growth are as follows:

This growth pattern will allow for two things: 1) Reach the maximum capacity of student enrollment and allowing for as many students on Guam to experience iLACS, 2) Allow for funding that will help expand the programs of iLACS.

FARM to TABLE PROGRAM

iLACS is working with the community and key vendors to expand our agriculture program. This program is designed to teach elementary students the health benefits of eating more produce, the need for Guam to look into more ideas to be self-sustaining, and to explore the engineering design of agriculture and irrigation.

ACCREDITATION

iLACS has submitted their application for WASC candidacy. iLACS is currently waiting for WASC to schedule the initial visit, which is to occur either in the Spring or Fall of 2018.

FUTURE CHALLENGES

President Trump's Tax Cuts and Jobs Act of 2017 requires a budget cut for the remainder of Fiscal Year 2018 for the entire GovGuam. Charter schools' per pupil cost will be reduced proportionately. ILACS will need to find additional funding sources such as grants and donors to cover forecasted shortfall due to budget cuts.
