## **About Us**

The Judiciary of Guam is the third branch of the Government of Guam that is charged with interpreting the laws of the U.S. Territory of Guam. The Judiciary is comprised of the Superior Court of Guam and the Supreme Court of Guam of which both the trial and appellate courts provide for the settlement of disputes between parties and protects the rights of individuals as mandated in the Organic Act of Guam and the Constitution of the United States of America. The Judicial Council of Guam is the governing body of the Judiciary of Guam. Pursuant to law, it is composed of all full-time Justices of the Supreme Court, the Presiding Judge of the Superior Court, and an appointed Superior Court Judge. The current composition of the Judicial Council was created in 2003, and in 2004, after an amendment to the Organic Act of Guam effectuated by the United States Congress in Public Law 108-378, the judicial branch was declared a separate and co-equal branch of the Government of Guam. Under 48 U.S.C. § 1421-1(b), the Chief Justice of Guam retains all supervisory authority of the judicial branch. With the advice of the Judicial Council, the Chief Justice governs the divisions and offices within the Judiciary of Guam.

## **Demographics**

As of September 30, 2017, the Superior Court of Guam received 14,412 filings and the Supreme Court of Guam recorded 72 total case filings. The top offenses charged in Guam's trial courts in 2017 were Family Violence, Driving While Under the Influence of Alcohol, Possession of Schedule II Controlled Substance, Assault-Recklessly Cause/Attempt to Cause Bodily Injury and Harassment. Guam's appellate court issued opinions in 13 civil cases, 14 criminal cases and one certified guestion in 2017.

Guam Law mandates that when there is a permanent vacancy of an associate justice of the Supreme Court or judge of the Superior Court, the Governor of Guam shall appoint a replacement. With input from the Judicial Council of Guam and the Guam Bar Association, the appointment process considers character, reputation in the community, experience in the practice of law, and judicial temperament. A judicial officer appointment shall be confirmed by the Guam Legislature.

## **OUR PERFORMANCE**



**Filing=** the act of submitting a document to the clerk of a court for the court's immediate consideration and for storage in the court's files.

**Opinion=** A statement that is prepared by a judge or court announcing the decision after a case is tried which includes a summary of the facts, a reading of the applicable law and how it relates to the facts, the rationale supporting the decision, and a judgment.

What is a trial court? 7 Guam Code Annotated § 3105 (2005) mandates that the Superior Court of Guam, the island's court of general jurisdiction, are the courts where cases start. In the trial court, both sides present evidence to show their version of what happened in a dispute. They have judges which decide what evidence can and cannot be used and often decide the outcome of the case. The trial court often utilizes a jury or a group of citizens who listen to the facts and make decisions about the case.


What is an appellate court? The Organic Act of Guam (48 U.S.C.A. § 1424-1) 7 Guam Code Annotated Chapters 1 through 50 creates a judicial branch of the Government of Guam with the Supreme Court of Guam as the supervisory authority over the trial courts. They focus on questions of law and whether the law was applied accurately in trial court disputes.

## **OUR OUTLOOK**



#### What's Next in 2018 Implementation of the Safe Streets Act and the Establishment of a DWI Treatment Court

The formulation of this legislation was led by the Attorney General of Guam in collaboration with stakeholders, including the Guam Police Department Highway Division, Public Defender Services Corporation, Alternate Public Defender, Guam Behavioral Health and Wellness Center, and the Guam Department of Public Works Highway Safety Office. Public Law 34-107 modernizes Guam's DWI laws and adopts a treatment court to enhance public safety, lower costs, improve the quality of life of intransigent DWI offenders, and reduce recidivism in their cases. Participants become eligible after being identified as medium- to high-risk for criminogenic behaviors and high-need alcohol-dependent offenders, who may have co-occurring disorders; are repeat DWI violators or first-time violators with a BAC at 0.15 and higher.



### Legislation to formalize the Criminal Justice Automation Commission

Twenty-five years ago the Superior Court of Guam was asked to construct the Criminal Justice Information System. Thus began an outstanding collaboration between the judicial and executive branches through the Criminal Justice Automation Commission. Adoption of proposed CJAC legislation will further support the Guam Integrated Criminal Justice Information System and develop plans for an inter-operable law enforcement communications system by formalizing the Commission.



### Addition of an Eighth Trial Court Judge

Courts are vital to maintaining the infrastructure of our society. Although not always noticeable, it becomes more apparent in the face of rapidly changing economic and social landscapes. Businesses, government, and individuals need access to fair, quick, and neutral dispute resolution.

There is no doubt that in measuring the modern business climate of Guam, the due-process methods and the timeliness of the disposition of lawsuits plays a significant role in the result.

Furthermore, backlogs drive up local incarceration costs, put the rights of the accused in jeopardy, impact businesses' ability to operate in Guam and Micronesia, and harm families. The Judiciary of Guam is seeking support to fund an eighth judge for the Superior Court of Guam. With the backing of the Guam Chamber of Commerce, our Consular Corps, and other community stakeholders, adding a new judge is necessary today to ensure the effective and efficient delivery of justice.
