OUR MANDATES

- Regularly study and update CHamoru orthographic rules; notify public and private institutions of changes.
- Collaborate with CNMI leaders to standardize CHamoru orthography and address regional differences.
- Advise media, institutions, and individuals on aligning content with CHamoru grammar and orthography.
- Provide updates to the CHamoru-English Dictionary.
- Establish a CHamoru translation service with a structured fee system for public/private use and media.
- Develop standardized, culturally relevant curricula for Guåhan's schools and higher education institutions.
- Conduct research and produce multimedia and print materials on CHamoru language, history, and culture.
- Coordinate with educational institutions and businesses to ensure proper use of standardized orthography and grammar.
- Provide training to enhance understanding of CHamoru heritage.
- Act as a clearinghouse for accurate representations of CHamoru language, history, and culture.
- Partner with the Bureau of Statistics and Plans to survey CHamoru language use and intergenerational transmission.
- Serve as the Guam Place Names Commission, to promote culturally and historically accurate naming criteria.
- Study and restore ancient CHamoru terminology and pronunciation of place names using current orthography.

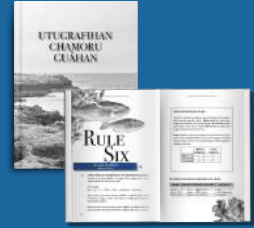

MINAPOT YAN CHINÁTSAGA CHALLENGES

- We are seeking a change in our legal status to become a public non-profit corporation. This will allow the Kumisión to seek funding from non-governmental sources and enable us to acquire donations from private entities. We would also be able to sell our products for the purpose of maintaining a revolving fund for future productions.
- The Kumisión has had to relocate multiple times since its establishment in 2017. We are in need of a permanent facility to house our staff and programs, recording studio, training rooms, archives, genealogy lab and research center, and to provide adequate space for community outreach and collaboration with partners.
- The process of compensating our traditional experts and knowledge-bearers for their wisdom and service is cumbersome and requires licensure and vendor status that our elders do not have access to. Creating alternative procurement procedures that meet compliance requirements while acknowledging and honoring traditional cultural practices is another major hurdle we constantly encounter.
