# **Executive Summary Government of Guam Issuance of Citizen-Centric Reports for FY 2021 and FY 2022** Report No. 24-10, October 2024

Our audit of Government of Guam (GovGuam) entities' compliance with mandated Citizen-Centric Reporting (CCR) for fiscal years (FY) 2021 and 2022 found the following (as of October 16, 2024):

- 61 of 67 entities (or 91 %) issued their FY 2021 CCRs. Of the 61, 42 entities fully complied, 19 entities were partially compliant, and six were non-compliant.
- 59 of 67 entities (or 88 %) issued their FY 2022 CCRs. Of the 59, 35 fully complied, 24 partially complied, and eight were non-compliant.




Figure 1: Compliance Breakdown

Fully compliant means the entity has issued its CCR and met all criteria under Title 1 Guam Code Annotated (GCA) Chapter 19 § 1922 (a). This includes: submissions of their CCR in electronic format (via pdf, e-mail attachment) to the Public Auditor and the Speaker by their respective deadlines (60 calendar days after the release of their independent audit); and posting their CCR on their respective websites. Partially compliant means the entity issued their CCR, but did not meet all criteria under 1 GCA Chapter 19 § 1922 (a), and non-compliant means the entity did not issue a CCR. See Figure 1 below for the Compliance Breakdown.

Only twenty-nine (29) entities fully complied with the mandated CCR requirements for both FY 2021 and 2022. As a result, these entities have demonstrated their commitment to providing readily available and understandable financial data to the people of Guam.

## **Non-Compliant Entities**

As shown in Table 1 below, six entities were non-compliant for FY 2021 and eight entities were non-compliant for FY 2022. Of these non-compliant entities, five were non-compliant for both FY 2021 and FY 2022.

These non-compliant entities have neglected their responsibility to:

- Provide information regarding government operations and how taxpayer dollars are spent; and
- Communicate and make government financial information available in a simple and understandable format accessible to citizens.

# **Partially Compliant Entities**

Nineteen entities were partially compliant for FY 2021, and 24 entities were partially compliant for FY 2022. The most common cause for partial compliance in both fiscal years was late submission of CCRs to OPA and the Speaker of the Guam Legislature.

Several entities only achieved partial compliance after they received notification from OPA regarding this compliance audit. For FY 2021, these entities were the Department of Corrections (DOC), Department of Labor (DOL), Guam Homeland Security/Office of Civil Defense (GHS/OCD), Office of the Governor (GOV), and Serve Guam Commission (SGC); For FY 2022, DOC, Guam Fire Department (GFD), GHS/OCD, Office of Technology (OTECH), GOV, and SGC were partially compliant. Without OPA's notification, these entities would be non-compliant.

# Application of AGA's Four-Page Format for Citizen-Centric Reporting

Eleven of the 61 CCRs issued for FY 2021 and nine of the 59 CCRs issued for FY 2022 exceeded the recommended four-page format. Although entities' compliance with §1922(b) was not a factor in our determination of overall compliance with the CCR mandate, we encourage the application of the AGA's suggested content guidelines when developing a CCR – which recommend a concise four-page format for CCRs.

# AGA National Certificate of Excellence and AGA Guam Chapter Best Citizen-Centric Report Contest

AGA National awards the Certificate of Excellence in CCR to recognize high-quality CCRs that incorporate its high standards of content, visual appeal, and readability, distribution, and timeliness in report. Nine GovGuam entities received the Certificate of Excellence in CCR for both FY 2021

These entities are models of effective application of the AGA's CCR Suggested Content, and all GovGuam entities are encouraged to use them as examples when preparing their respective CCRs.

### Conclusion

The CCR mandate was introduced as a way to improve GovGuam entities' accountability and transparency by simplifying government financial information to help Guam's citizens better understand the services provided by the entities and at what cost. We commend those entities that continue to comply with the mandate and those that have been awarded AGA National's Certificate of Excellence in CCR and AGA Guam Chapter's Best CCR awards.

# Introduction

Government of Guam (GovGuam) entities are mandated to issue a Citizen-Centric Report (CCR) to ensure that our government provides more readily available and understandable financial data to the people of Guam.

This report presents the results of our review of GovGuam entities' issuance of CCRs for Fiscal Year (FY) 2021 and FY 2022 pursuant to Title 1 of the Guam Code Annotated (GCA) Chapter 19 §1922(a).

Our audit objective was to determine GovGuam entities' compliance with CCR issuance requirements as prescribed in 1 GCA §1922(a). Specifically, we reviewed the entities':

- Submissions of FY 2021 and FY 2022 CCRs to the Public Auditor and the Speaker in electronic format (via .pdf e-mail attachment) by their respective deadlines (no later than 60 calendar days after the release of their independent audit); and
- Postings of FY 2021 and FY 2022 CCRs on their respective websites.

In addition, we determined if CCRs issued met the four-page format as recommended in 1 GCA § 1922 (b) and AGA's CCR content guidelines.

Refer to Appendices 1 and 2 for the objective, scope, methodology, and prior audit coverage.

Per 1 GCA §1922(a), every director, administrator, president, or head of a GovGuam entity, including line agencies, autonomous and semi-autonomous agencies, public corporations, the Guam Mayors' Council, the Courts of the Judiciary of Guam and the Guam Legislature shall submit an annual CCR in electronic format (via .pdf e-mail attachment) to the Public Auditor of Guam and the Speaker of the Guam Legislature. The CCR is due no later than 60 calendar days after the release of a government entity's independent audit report for each fiscal year and shall be posted on the entity's website.

For autonomous entities, their deadline varied depending on the issuance of their financial audits. For all other entities, their deadline was based on the issuance of the GovGuam-wide financial audit.

### **Background**


The AGA created the CCR to simplify government financial information to help citizens better understand the services provided by their government and at what cost. In 2010, Public Law 30-127 mandated CCRs from GovGuam entities based on the following legislative findings:

- Governments have a responsibility to provide information regarding government operations and how taxpayer dollars are spent; and
- Government financial information should be communicated and accessible to citizens in a simple and understandable format.

The Office of Public Accountability (OPA) encourages all citizens to view the CCRs on the entities' websites or OPA's website at <a href="https://www.opaguam.org">www.opaguam.org</a>.

While 1 GCA §1922(b) states that the CCR should be in the most current format suggested by AGA, it also suggests the following content for each page:

# **Results of Audit**

Our audit of GovGuam entities' compliance with the mandated CCR reporting for FYs 2021 and 2022 found the following (as of October 16, 2024):

- 61 of 67 entities (or 91%) issued their FY 2021 CCRs. Of the 61, 42 entities fully complied, 19 entities were partially compliant, and six were non-compliant.
- 59 of 67 entities (or 88%) issued their FY 2022 CCRs. Of the 59, 35 fully complied, 24 partially complied, and eight were non-compliant.

Table 3 below shows the overall compliance of the entities required to submit CCRs for FY 2021 to FY 2022.

### **Fully Compliant Entities**

For FY 2021, 61 of 67 entities (or 91%) issued a CCR. Of the 61, 42 entities fully complied by timely submitting their CCRs to both the OPA and the Speaker, as well as posting the report on their websites. See Appendix 5 for lists of GovGuam entities deemed fully compliant for FY 2021.

For FY 2022, 59 of 67 entities (or 88%) issued a CCR. Of the 59, 35 entities fully complied. See Appendix 7 for lists of GovGuam entities deemed fully compliant for FY 2022.

Only twenty-nine (29) entities fully complied with issuing their CCRs for both FY 2021 and 2022.


- 1.) Although GALC is fully compliant for FY 2021 and 2022, we note that their FY 2021 CCR was posted on their website after we issued their Partial Compliant Notification letters in August 2024.
- 2.) For both FY 2021 and FY 2022, the CSC and GALC issued CCRs that are more than the AGA-suggested four-page format. DYA's FY 2021 CCR was longer than the four-page format.

# **Partially Compliant Entities**

Throughout FY 2021 to FY 2022, the most common cause for partial compliance was late submission to OPA and the Speaker. Several agencies became partially compliant after notification from OPA regarding this compliance audit.

For FY 2021, of the 61 entities that issued a CCR, 19 were partially compliant for not meeting all criteria pursuant to 1 GCA §1922(a). Of these entities, the DOL, GHS/OCD, GOV, DOC, and SGC issued FY 2021 CCRs after OPA notification regarding this compliance audit. See Appendix 6 for a list of GovGuam entities that were deemed partially compliant for FY 2021.

Table 4 below shows the partial compliance breakdown of GovGuam entities for FY 2021.



For FY 2022, of the 59 entities that issued a CCR, 24 were partially compliant for not meeting all criteria pursuant to 1 GCA §1922 (a). Of these entities, GFD, GHS/OCD, OTECH, DOC, GOV, and SGC issued FY 2022 CCRs after notification of this compliance audit. ## **Non-Compliant Entities**

As shown in Table 6 below, six entities were non-compliant for FY 2021 and eight entities were non-compliant for FY 2022. Of these non-compliant entities, five were non-compliant for both FY 2021 and FY 2022.

These non-compliant entities have neglected their responsibility to:

- Provide information regarding government operations and how taxpayer dollars are spent;
   and
- Communicate and make government financial information available in a simple and understandable format accessible to citizens.

# Application of AGA's Four-Page Format for Citizen-Centric Reporting

According to 1 GCA §1922(b), the CCR should follow the most current format proffered by the AGA. Although this audit did not monitor the contents of the CCRs, we suggest the application of the AGA suggested content guidelines when developing a CCR. AGA's concept of a CCR is a visually appealing "four-page" document that includes:

1. Government entity mission, vision, and goals, plus community demographic information, such as population figures and other interesting items.

- 2. Performance information for key service areas, demonstrating progress (or not) over the prior year's efforts.
- 3. Detailed revenue and expense information highlighting changes from prior years(s).
- 4. A look to the future and "what's next" in the year ahead, plus any foreseen challenges in meeting stated goals.

Content guidelines can be found at <a href="www.agacgfm.org">www.agacgfm.org</a> and in Appendix 4 of this report. Although entities' compliance with §1922(b) was not a factor in our determination of overall compliance with the CCR mandate, we suggest the application of the AGA's suggested content guidelines when developing a CCR – namely the four-page format.

We note that the purpose of a CCR is to simplify communication between the government and its citizens, which could be achieved through a condensed form of reporting (i.e. four-page format); however, we observed that 11 of the 61 CCRs issued for FY 2021 and nine of the 59 CCRs issued for FY 2022 exceeded four pages. The CSC, DYA, and GALC, which we determined to be fully compliant for both FY 2021 and FY 2022, produced CCRs that were longer than the AGA's suggested four-page format; the CSC and GALC's CCRs for both FY 2021 and FY 2022 were longer than the suggested format while DYA's FY 2021 CCR was longer than the suggested format. See Table 7 below for GovGuam entities that issued FY 2021 and FY 2022 CCRs exceeding the four-page CCR format.

GovGuam entities should strive to have their CCRs meet the four-page format as recommended in 1 GCA §1922(b). We encourage GovGuam entities to revisit AGA's CCR Suggested Content for guidance in simplifying government financial information to help Guam's citizens better understand the services provided by the entities and at what cost.

Furthermore, GovGuam entities may consider submitting their four-page CCRs for consideration in AGA National's Certificate of Excellence in CCR and AGA Guam Chapter's Best CCR Contest. The entities that have won the AGA National's Certificate of Excellence in Citizen-Centric Reporting and the AGA Guam Chapter's Best Citizen-Centric Report awards produced CCRs with no more than four pages.

## AGA National Certificate of Excellence and AGA Guam Chapter Best CCR Contest

AGA National awards the Certificate of Excellence in CCR to recognize high-quality CCRs that incorporate its high standards of content, visual appeal, readability, distribution, and timeliness in reporting. Each fiscal year, AGA Guam Chapter holds the Best CCR contest, which awards GovGuam entities for producing the best CCR based on strict guidelines and eligibility requirements. Refer to Appendix 10 for guidelines on AGA Guam Chapter's Best CCR Award. The following entities were awarded the top three best CCRs for FY 2021 and FY 2022:

These entities are models of effective application of the AGA's CCR Suggested Content, and all GovGuam entities are encouraged to use them as examples when preparing their respective CCRs.

# **Conclusion**

As of October 16, 2024, our audit determined the following:

- 61 of 67 entities (or 91%) issued their FY 2021 CCRs. Of the 60, 42 entities fully complied by timely submitting their CCRs to both the OPA and Speaker. Also, posting the CCR on their websites. The remaining 19 entities were partially compliant for issuing their CCR but only met some requirements.
- 59 of 67 entities (or 88%) issued their FY 2022 CCRs. Of the 59, 35 entities fully complied and 24 entities partially complied.

Six of 67 entities (or 9%) were non-compliant for FY 2021 because they did not submit their CCR to the OPA and the Speaker, nor did they post it on their website. Additionally, 8 of 67 entities (or 12%) for FY 2022 did not submit their CCR to the OPA and the Speaker, nor did they post it on their website. As such, these noncompliant entities neglected their responsibility to:

- Provide information regarding government operations and how taxpayer dollars are spent; and
- Communicate and make government financial information available in a simple and understandable format accessible to citizens.

Of these non-compliant entities, the DCA, GEPA, GPD, GVAO, and OCME were non-compliant for FY 2021 and FY 2022.

The CCR mandate was introduced as a way to improve GovGuam entities' accountability and transparency by simplifying government financial information to help Guam's citizens better understand the services provided by the entities and at what cost. Eleven of the 61 CCRs issued for FY 2021 and nine of the 59 CCRs issued for FY 2022 exceeded the four-page format as noted in 1 GCA §1922(b). Although entities' compliance with §1922(b) was not a factor in our determination of overall compliance with the CCR mandate, we suggest the application of the AGA's suggested content guidelines when developing a CCR – namely the four-page format. Furthermore, GovGuam entities may consider submitting their four-page CCRs for consideration in AGA National's Certificate of Excellence in CCR and AGA Guam Chapter's Best CCR Contest.

We commend those entities that continue to comply with the mandate and those that have been awarded AGA National's Certificate of Excellence in CCR and AGA Guam Chapter's Best CCR awards. These entities are setting the standard for CCRs, and all GovGuam entities are encouraged to achieve this feat.

# **Appendix 1:**

# Objective, Scope, and Methodology

Our audit objective was to determine GovGuam entities' compliance with CCR issuance requirements as prescribed in 1 GCA §1922(a). Specifically, we reviewed the entities:

- 1. Submissions of FY 2021 and 2022 CCRs to the OPA and the Speaker; and
- 2. Postings of FY 2021 and 2022 CCRs on their respective websites.

In addition, we determined if CCRs issued met the four-page format as recommended in 1 GCA § 1922 (b) and AGA's CCR content guidelines.

In this audit, "entities" refers to GovGuam agencies, including line agencies, autonomous and semiautonomous agencies, public corporations, the Mayors' Council of Guam, the Courts of the Judiciary of Guam, and the Guam Legislature.

The scope of our audit covered CCRs required for FY 2021 through 2022, as of October 16, 2024.

To accomplish our objective, we completed the following:

- Sent memoranda to all GovGuam entities reminding them of the FY 2021 and FY 2022 CCR submission deadlines, due 60 days after the release of their independent financial audit report.
  - Memo dated August 9, 2022, for FY 2021 CCRs, which were due September 19, 2022.
  - Memo dated December 22, 2023, for FY 2022 CCRs, which were due January 22, 2024.
- Reviewed CCR laws, guidelines, prior audits, hotline tips, and other relevant information.
- Reviewed GovGuam entities' websites for posting of CCRs.
- Reviewed the Guam Legislature's website for any CCR transmittals to the Speaker.
- Reviewed number of pages for each CCR submitted.
- Verified with OPA staff if CCRs were received, whether via e-mail or in print.
- Corresponded via telephone and e-mail with entities lacking submissions (to ensure compliance was not involuntarily missed).
- On August 16, 2024, and August 19, 2024, we informed the 67 GovGuam entities of their compliance status and opportunities to improve, if any, future CCR submissions.

Due to the nature of this engagement, we did not assess internal controls over the information systems used to gather the necessary data to prepare the entities' CCRs.

We conducted this audit in accordance with the standards for performance audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States of America. These standards require that we plan our audit objectives and perform the audit to obtain sufficient and appropriate evidence to provide a reasonable basis for our findings and conclusions based on our audit objectives. With the exception of not assessing internal controls, we believe that the evidence obtained provides a reasonable basis for our findings and conclusions based on our objectives.

# **OPA Report No. 21-07**

Of the 65 GovGuam entities required to submit CCRs, 55 entities (or 85%) issued FY 2020 CCRs, which was an increase from the 50 entities (or 77%) that issued FY 2019 CCRs. Of the 65 entities required to submit CCRs, 52 (or 80%) issued FY 2018 CCRs, a decrease from the 57 entities (or 89%) that issued FY 2017 CCRs. For FY 2017, only 64 entities were required to submit CCRs compared to the 65 entities that were required to submit CCRs in FY 2018. The following 3 entities did not issue CCRs for FY 2017, FY 2018, FY 2019, and FY 2020:

- 1. Department of Parks and Recreation
- 2. Hagatna Restoration and Redevelopment Authority
- 3. Office of Technology

Although not required to submit a FY 2017 CCR, OTECH was non-compliant for the period because they did not submit a CCR for FY 2018 to FY 2020.

Of the 57 GovGuam entities required to submit CCRs, 51 entities (or 89%) issued FY 2016 CCRs, which was a decrease from the 52 entities (or 91%) that issued FY 2015 CCRs. The following 4 entities did not issue CCRs for FY 2016 and FY 2015:

- 1. Department of Agriculture
- 2. Department of Integrated Services for Individuals with Disabilities
- 3. Guam Homeland Security/Office of Civil Defense
- 4. Office of the Governor

## **OPA Report No. 15-08**

Of the 57 GovGuam entities required to submit CCRs, 49 entities (or 86%) issued FY 2014 CCRs, which was an improvement from the 45 entities (or 79%) that issued FY 2013 CCRs. The following 5 entities did not issue CCRs for FY 2014 and FY 2013:

# P.L. 30-127 An Act Relative to Adopting the AGA's "CCR" Initiative

**Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds that the foundation of democracy is based on governments being answerable to their citizenry and, as such, having a responsibility to provide information regarding government operations, most notably in regards to how taxpayer dollars are spent.

*I Liheslatura* further finds that governments should provide such information in an easily understandable and accessible manner. Financial reports are often too lengthy and too technical for the average person to understand and even more so when discussing the enormous amounts of money spent by various governments each year.

Studies by the Association of Government Accountants (AGA) on the effectiveness of government fiscal reporting have shown that taxpayers feel they are entitled to transparent financial management information, and that their governments have an obligation to provide such information. Unfortunately, surveyed citizens also feel that their governments are failing to meet their reporting needs, and their poor performance has created a problem of trust between citizens and their government.

Governments need new and innovative means of communicating to overcome these challenges, and the AGA "Citizen-Centric Report" initiative is designed to help remedy this.

Therefore, it is the intent of *I Liheslaturan Guåhan* to adopt this initiative as an attempt to ensure that our government provides more readily available and understandable financial data to the people of Guam.

# Title 1 GCA Ch. 19 §1922. The "Citizen-Centric Report"

- (a) [...]
- (b) Content Guidelines.
  - (1) Said report should be in the most current format proffered by the AGA, and currently suggested as follows:
    - (A) Page one (1) of the "Citizen-Centric Report" should include a brief table of contents, and shall contain information about the entity, including but not limited to, the entity's vision statement, strategic goals, operational structure, and demographics.
    - (B) Page two (2) of the "Citizen-Centric Report" should reflect a performance report based on a summary of the entity's key missions and/or services and possible outcome measures.

- (C) Page (3) of the "Citizen-Centric Report" should provide a clear snapshot of financial data as it relates to the performance report presented in page two (2). This portion of the report should address the entity's cost for services provided and by what means those costs were covered.
- (D) Page four (4) of the "Citizen-Centric Report" should present the entity's forecast of future challenges and economic outlook.
- (2) Miscellaneous information, including, but *not* limited to, information sources, entity contact information, and feedback options, may be included in sections throughout the report.
- (3) Additional details regarding the content guidelines for the compilation of a "Citizen-Centric Report" can be found in Appendix "A", attached herein.

## (c) Design Guidelines.

(1) The design of a "Citizen-Centric Report" is just as important as the content. A report will only be effective if it is read and referenced; thus, it should be visually appealing. The AGA, the birthplace of the "Citizen-Centric Report" initiative, has created guidelines for the design of "Citizen-Centric Reports" to include suggestions for design considerations of visual appeal and readability, physical layout, colors, images and graphics, and type and fonts. The AGA also provides suggestions for publishing software and report distribution.







# AGA Certificate of Excellence in CCR

AGA offers a Certificate of Excellence in CCR for entities that prepare and distribute a high-quality CCR. To be eligible for the certificate, governments must abide by the program's high standards for report content, visual appeal, readability, distribution, and timeliness in reporting, as outlined in the Judging Guidelines below.

# **Judging Guidelines**

AGA will examine each CCR and make suggestions for improvement. The report must be free of technical accounting language. In addition, the CCR must include the following elements to be eligible for the Certificate of Excellence:

- 1. How the entity is organized and operates, including items such as a vision statement and strategic goals.
- 2. Key accomplishments in mission and service, along with selected performance measures.
- 3. Detailed trend information highlighting changes from prior year(s), or a statement explaining why trend data is not yet available.
- 4. Bar graphs and/or pie charts to illustrate revenues and expenses.
- 5. Audit information, such as a statement affirming a clean audit opinion and a link to the full audit report.
- 6. Future challenges for the government.
- 7. Requests for citizen feedback, such as "We want to hear from you. How do you like our report? Should it include other information? Please let us know at [insert your contact details].
- 8. Pictures and other graphics to make the report visually appealing.
- 9. Proof that the CCR was distributed in a hard copy, on the website, and/or in a newspaper.
- 10. The CCR logo to promote the program's brand.

No fees are charged to participate in the CCR program.

AGA Guam Chapter's Best CCR Contest awards the GovGuam entity that produces the best CCR each fiscal year based on strict guidelines and eligibility requirements.

# **Eligibility Requirements**

All GovGuam entities that completed the fiscal year Audited Financial Statements; submitted a CCR to the Office of Public Accountability and Speaker of Guam Legislature within 60 calendar days after the issuance of the Audited Financial Statements, and posted the CCR on the entity's website are eligible for this award.

### **GovGuam CCR Evaluation Form**

AGA Guam Chapter utilizes the GovGuam CCR Evaluation Form to rate Citizen-Centric Reports (CCRs) submitted by GovGuam entities. Each criterion listed below is rated on a scale from 1-5, with 1 rating poor and 5 rating excellent:

- 1. Is the agency qualified to participate in GovGuam CCR award?
- 2. How the entity is organized; why they exist; use of the latest CCR logo
- 3. Agency's Demographics (population, income per capita)
- 4. Mission and vision statements, strategic goals, services, and activities it offers
- 5. Listing of key leaders and contact information for further engagement
- 6. Key service areas and performance over the past couple of years
- 7. Progress toward strategic goals and deliverables
- 8. Recent accomplishments for non-financial outcomes
- 9. Detailed trend information highlighting changes from prior year(s), or a statement explaining why trend data is not yet available
- 10. Revenues and expenses for key service areas (salaries, facilities, taxes, grants, education, etc.) where does funding come from, and where does the money go?
- 11. Explanation of changes in revenues/expenses from prior years, with the inclusion of trend data
- 12. If an audit was conducted, and the results of the audit
- 13. A link to their audited financial statements for more (detailed) information
- 14. What challenges are expected in the coming year economic changes, tax cuts or increases, unemployment, education, environmental challenges
- 15. Have priorities changed; if so, what influenced the change? Will there be new/different services for citizens?
- 16. What is the agency's outlook?
- 17. A link to their website for more information, the location of detailed reports, and other supporting
- 18. Design Guidelines Requirements: visually appealing, readability, physical layout, colors, images, and graphics were consistent, type and fonts were consistent
- 19. Was CCR sent to OPA, Guam Legislature, and posted on the agency's website by their due date?
